You are also required to read and understand the summary entitled "Legal and Policy Obligations of Members", and design your programs to conform to them. These documents are in brochure holders on the wall at the studios.

2. I understand that to be qualified and authorised to broadcast my own program and use Radio Northern Beaches facilities, I must:
 - a) Be a financial member of the Manly-Warringah Media Co-operative Ltd.
 - b) Agree to adhere to the stated policies of Radio Northern Beaches contained in the Policies and Procedures Manual.
 - c) Have attended a Radio Workshop or been granted immunity by the board.
 - d) Have had 8 hours of tuition with a training member of the Co-op.
3. I understand that when I am granted an 'on-air slot, that I am responsible for everything broadcast during that time. If I am unable to attend, I should contact the Programming Co-ordinator. This is a responsibility I cannot delegate to an unqualified member.
4. I understand that the definition of a 'guest' on my radio program is limited to people who participate in my program a maximum of three times a quarter. Anyone who attends more frequently needs to also be a financial member of the Manly-Warringah Media Co-operative Ltd.
5. I understand that membership of the Co-op involves more than just broadcasting, and that I should participate in other operational aspects of the radio station that keeps the station viable.
